The founder members had a great awareness of the importance of higher education, which led them to establish the Navnirman Shikshan Sanstha's S. P. Hegshetye College of Arts, Commerce & Science, at Ratnagiri in 2001.

The college is affiliated to the University of Mumbai & offers the undergraduate courses in different subjects. The college has an excellent infrastructure. College has enriched library with latest books & journals . Our students have participated in various Zones, District, University, State & National level competitions. The college has well advanced modern computer lab. College helps students to realize their goals & achieve them effectively with experienced & dedicated teachers. The college finds its responsibility towards community, women's empowerment, socio-economically backward class, environment consciousness, national harmony etc. And constantly address them through several co- curricular and extracurricular activities.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The college imparts education in faculties of Arts, Commerce, and Science. It offers UG and Certificate courses. Elective system is applied for B.A, B. Com, B.B.I, B.M.S, and B.H.S. whereas CBCS system is followed for all classes. Our college follows the curriculum prescribed by the University of Mumbai. The college ensures effective curriculum delivery through a well-planned systematic manner and documented Process. Planning for effective implementation of curriculum is done at the beginning of academic year with a focus on the objectives and goals of the college. The Academic Calendar is prepared at the beginning of the academic year as per University Academic Calendar. The practices such as maintaining academic calendar, departmental time table, annual teaching plan & attendance of the students etc. are implemented for effective delivery of curriculum. The college takes initiatives and conducts various students' centric methods that become more experiential, participatory and holistic. With the traditional methods the curriculum is delivered effectively through ICT tools and various teaching aids. Syllabus completion review is done by IQAC in each semester. Continuous internal evaluation is undertaken through well-established mechanism. The curricula is framed with well-defined Programme Outcomes (POs), Programme Specific Outcomes (PSOs) and Course Outcomes (Cos). Curriculum covered cross cutting issues relevant to Gender Environment and Sustainability, Human Values and Professional Ethics. The institution inculcates values related to environment and sustainability by organizing various extra-curricular activities. To improve the transaction of the curriculum, annual feedback on curriculum is collected from stake holders such as students, teachers, alumni and employers. Feedback is consolidated, evaluated, analysed and action is taken accordingly.

Teaching-learning and Evaluation

The college prospectus contains detail information about courses offered, eligibility criteria, admission procedure, scholarships, infrastructural facilities, academic calendar etc. The institution practices transparent process of admission for all the programmes as per the rules and regulations provided by Government of Maharashtra and University of Mumbai. The admissions are given on the basis of first come first serve. Care has been taken to provide adequate representation to SC/ST/OBC and other communities of the society. The college conducts various student centric methods that learning became more enhancing. Students representative are nominated in various college committees. The teachers use ICT in teaching, learning and evaluation. Teaching-learning practices include ICT-based methodology through Google Classroom and Meet, YouTube, PPTs, PDFs, videos; you tube links, e- sources, google forms, etc. the students actively participates in group discussions, seminars, essay writing competitions, poetry recitation competition, debates, wallpapers magazines etc. These events develop a sort of critical and creative thinking among the student. For the slow learners, remedial classes are offered to enhance their learning. Research projects are assigned to the advance learners. The teachers are recruited as per the policies of Government of Maharashtra. The average percentage of full time teachers against sanction post is 92.72%. In the institution, have 02 permanent faculties and 28 temporary faculties. Total 13.57 per cent teachers are Ph. D and NET, SET holders. The Continuous Internal Evaluation (CIE) is a comprehensive and robust. Academic performance of the students is evaluated through assignments, unit tests, attendance, seminar, quizzes, projects and group discussions at the end of semester examinations. There is a mechanism to deal with grievances related to college and university examinations. An examination committee is constituted to handle the issues regarding the evaluation process. POs and COs are displayed on college website and communicated to the students in induction Programmes. The formative and summative assessment methods are used for measuring the attainment of each PO's, and CO's. A strong mentoring system scheme is practiced through an established mechanism. There is a system of felicitation and awards for

meritorious students. Online student satisfaction survey regarding to teaching learning process is conducted.

Research, Innovations and Extension

The institution has framed policy and established the Incubation centre under Jidnyasa Research Committee for research promotion. Jidnyasa Research Committee takes continuous initiatives to inculcate research interest among the faculties and the students. The institution provides IT infrastructural facilities and required human resource support to the faculty members and students. Presently 2 faculty members has been awarded Ph.D. Faculty members are encouraged to write research articles & to apply for research projects. An amount of Rs. 107000/- has been received for research projects. Also 02 Minor research projects had been completed by faculties during last five years. The faculty members have published 08 research papers and articles in National & International Journals.

The college has organized 41 Seminars, Conferences & Workshops on Research Methodology, Intellectual Property Rights (IPR) and Entrepreneurship during the last five years. College had collaboration with 20 other institutes to exchange the knowledge among the faculty members & students. The college is organizing various extension activities with the active participation of teachers and students to the create awareness and responsibilities among the students regarding the common social issues i.e. International Yoga Day, Tree Plantation, Voters Awareness Rally, Polio Awareness Programme, Social Equity Week, Girls Security Programme, International Women's Day, Road Safety Programme, Corona Vaccination and Safety Awareness Programme. Faculty & students visited to Maher Ashram Ratnagiri and Avishkar Society for development of mentally handicapped. The students offer some clothes and donated stationary In 2018, Kerala state faced a natural flood disaster. For flood affected people, the students and staffs collected a fund and sent it to throught the Rastraseva dal. In the year 2019 the college donated grain and pulses to kolhapur sangali flood ted people and In year 2022 the college also distributed grain, pulses and necessary goods to the Chiplun flood affected people. At that time, the Lokmanya Tilak Memorial library Chiplun was filled with silt due to flood water. The students cleaned the entire library by vacuuming the sludge.Institution. Faculties achieved Awards & recognitions for their outstanding contribution for organizing & participating in extension activities & outreach programs in the neighbourhood society.

Infrastructure and Learning Resources

The college encompasses a well maintained green campus with construction of building is 3157.68 Sq. mtr. spread over an acre of land ensuring adequate infrastructure for teaching learning activities. The institution has well-furnished classrooms with adequate size desks, enough lighting with well ventilation, 04 smart TV classrooms, 4 LCD Projector Class room, one smart class , one seminar hall with LCD Projector and Two computer Lab. There are 60 computers with updated versions for office and students. The campus is supported with WiFi facility BSNL Broadband width of 200 mbps. To avoid power cut disturbance there are three invertors fitted in the office and computer Lab. 05 printers, 03 Printer with scanners, 2 Xerox machines. Expended Rs. 11,22904 Lakhs for infrastructure development augmentation during 2018-19 to 2022-23. The library is located on the third floor having an area of 1390.84 sq. ft. The library has partially automated with e-Granthalaya 3.0 Software. There are separate reading compartments for teachers and students in library. The institute played a proactive and supportive role in grooming students in sports. The institution has adequate facilities for sports and games. Indoor Game facilities: Carom board and Chess etc. the college have specious ground facilities to increase sport spirit among the students. Yoga practice is conducted in a separate place. Filtered Water (RO) Facility is made available for students, faculty and staff members. The college has a

canteen and parking area for students & staff.

Student Support and Progression

The students belonging to this area are economically backward. The student needs scholarships, financial support, freeships, welfare schemes, and carrier guidance. GOI, post metric scholarship, EBC, SC/ST, NT, VJNT and Minority Scholarships are made available to concerned students. Beside this Hindustan Petroleum Corporation LTD, Malala Scholarship, Shahu Maharaj Scholarship University of Mumbai financial assistance, are made available to the students. As per the state government norms, students belonging to the SC/ST, OBC and SEBC categories are receiving the financial assistance from the government. 30.03 % students benefited by Government scholarships. Apart from Government scholarships, college has the institutional practice of offering financial support to the deserving students. Academic endowments and prizes are given every year to the achievers at various levels. Departments, associations and committees in the college organize different capacity building and skill enhancement activities. 'Communication Skills in English' helps in capacity building and skills enhancement. Remedial Coaching Classes, Yoga, health and hygiene camps and Personal Counselling are made available for the welfare of Students. After completion of graduation courses 25.91% of the students go for higher education and join services as per their needs.

The Career Guidance and Counselling Cell encourage the students to take part in competitive exams. 01 student appeared in state/ national/ international level examinations. In 2018-19 the student Swapnil Dhanawde got 1st rank on Jaywant Dalvi One Act Play state level competition. In year 2022-23 student Shruti Fhanse got 2 state level runner up prices in Badminton. The Institution has a transparent mechanism for timely redressal of student grievances. Students and alumni representation in CDC, IQAC Committee ,Magazine Committee, NSS committee, Grievance Redressal Committee, Sports Committee, Cultural Committee etc. The students are encouraged to participate in sports, cultural competitions and social activities organized by the college as well as other institutions.

Governance, Leadership and Management

Governance of the Institution is the reflection of an effective leadership in tune with the Vision and Mission of the Institution. The management promotes education compatible with the goals and objectives. The vision of the college is "To provide quality education at affordable cost with special focus on economically backward and socially deprived students. To make them socially responsible and independent persons". The Institution encourages decentralization and promotes participative management with involvement of all stakeholders through CDC, IQAC and various committees for administration and academic process. The Institution ensures transparency and accountability in all its activities to the satisfaction of stakeholders. CDC acts as a link between Governing Council and the college. Internal coordination is effectively implemented by the Principal. The representation of the teachers and students in various committees ensured decision making policies. Various committees are formed to plan, coordinate and monitor periodical reviews of teaching, learning and extension activities. Regular meetings of IQAC and other committees helps in effective planning and implementation of institutional policies.

Perspective plan is prepared by IQAC under the recommendations of Governing council, CDC and Principal and deployed effectively. The efficacy of institutional bodies and their functioning is visible from policies, administrative setup, appointment & service rules and procedures and deployment of strategic plan. There is an effective implementation of e-governance in administration, finance and accounts, students' admission and

examination process. The institution has put several welfare measures for employees including EPF pension, various types of leaves, and uniforms for teaching and non-teaching staff. The teachers are provided with financial support to attend conferences/workshops, and to publish research articles.

The Institution has a well - planned resource mobilization policy. Principal is the in charge of the financial transactions. IQAC plays a vital role. IQAC consists of representatives of the management, teaching, non-teaching staff, students and alumni. Alumni Association conducts activities . IQAC is responsible for preparation of Self-Study Reports, and Performance Based Appraisal System. Academic and Administrative Audit, Environment Audit, Energy Audit, Gender Audit. The IQAC also organize FDP and collect feedback from various stakeholders.

- Women empowerment is the distinctiveness of the college. Strong devotion for over all development of the society is our prime aim.
- Rain water harvesting helps to recharge of bore on the campus.
- Organic composting plant is implemented for management of the organic degradable waste.
- Green and energy audit was done in the campus.
- Cleanliness drives are organized by the NSS. Dustbins are placed at the proper places.
- The Ramp facility is made available to support differently-abled students.
- Activities and programmes pertaining to cultural, regional, linguistic and socio-economic occasions are conducted as per circulars of Government and Academic Calendar.
- Faculty and students contribute in social causes and natural calamities. We worked as Corona Warriors during Covid-19 pandemic. Students and staff distributed food packets and masks to the adopted village Dande Adam.
- The college contributed towards the floods affected in Kerala and Maharashtra.

1. Multidisciplinary/interdisciplinary:

	 designed by the University of Mumbai. The B. A., B. Com, B.M.S, B.B.I programs have an elective mechanism, giving students the freedom to choose subjects of their choice. B.A., B.Com, B.M.S, B.B.I, B. Sc Computer Science, B. Sc. Information Technology & B. Sc. Hospitality Studies programs follow the CBCS pattern. To address the needs of students, the college has introduced a three-year B.B.I (Banking and Insurance) course. Additionally, the college offers short-term certificate courses. Faculty members actively participate in faculty development programs and seminars on the National Education Policy 2020. The college is introducing more multidisciplinary subjects and identifying program-learning outcomes along with course outcomes. These outcomes define specific knowledge and skills that enable the learners to achieve their objectives.
2. Academic bank of credits (ABC):	The college is following policies related to Academic Bank of Credit (ABC) to facilitate the academic mobility of students. The college is also adopting the policy guidelines to ensure appropriate credit transfer. The college has been following the CBCS pattern adopted by the University of Mumbai. The university has informed the college about the necessary actions for the implementation of the Academic Bank of Credits. The faculties of our institute have instructed the stakeholders accordingly. The college has appointed a faculty member as the Nodal officer to execute the guidelines provided by the University. The college has also been instructed to create ABC accounts for all students in Digi Locker. The students have successfully created their ABC accounts and their ABC IDs have been forwarded to the University of Mumbai.
3. Skill development:	The college has adopted a policy to offer skill development programs for the overall development, aiming to address the requirement of 21st-century skills in society. Career-oriented courses such as basics of Computer, spoken English and written, environmental studies, bakery and food production, geographical survey Technics, business management, tourism studies, agricultural based studies, hygiene related courses have been successfully completed during the academic year. All departments organized various skills based programs enabling students to explore future employment pathways. Our college

	actively participates in this initiative, providing skills among our students opportunity to develop entrepreneurial skills.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The college actively engages in spreading the rich heritage of our country and traditional knowledge in the fields of arts, literature, and culture. We have adopted a trilingual approach for our undergraduate programs, utilizing English as an international language, Hindi as the national language, and Marathi as the state/regional language in our curriculum. Our specialization lies in Marathi, Hindi, and English literature. Social science subjects like Geography, History and Economics are taught in a bilingual mode, using both Marathi and English. To preserve and promote Indian culture and tradition, every year college organizes various programs. Our language and social science department actively arranges different activities to develop language skills among students. Hindi din, Marathi Bhasha Din, Elocution Competition, Field Visits, Theme Dinner programs have organized to get knowledge about Indian culture and language.
5. Focus on Outcome based education (OBE):	The college has implemented the Choice-Based Credit System (CBCS) pattern of the University of Mumbai since the academic year 2017-18 for the undergraduate courses. In accordance with the CBCS guidelines, the university has reconstructed the syllabus for all the programs. The university has included the course and program outcomes as objectives in the restructured programs. At the end of the academic year, the faculty members engage in discussions with the students regarding these outcomes. We employ various methods to verify the attainment of these outcomes. Guests lectures, Industrial visits, Internship, Seminars has introduced in the college.
6. Distance education/online education:	The college is doing efforts to apply appropriate techniques, resources and modern IT tools. Considering the convenience of the students, faculty members utilized various technological tools during the COVID-19 pandemic. They made use of online teaching platforms such as Google Classroom, Zoom and Google Meet. Additionally, students benefited from the use of YouTube links for teaching and learning purposes.

Regarding teacher's constituency election. Teachers are also encouraged for their Voting rights. Various awareness workshops and seminars have arranged by Tahasil and SDO office in the college campus under the ELC for the awareness of voting. Various rally's and ran go li, posters presented for the awareness of the society during the elections in the nearby villages.

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Our institution is affiliated to University of Mumbai. The syllabus of all courses is prepared revised, and updated by the Board of Studies of the university. For the effective implementation of curriculum, various action plans have been taken. The HODs allocates course curriculum to the teacher and prepare timetable accordingly. The HODs encourages the teachers to prepare teaching plan and get approval by the Principal in departmental meetings. Institution organizes departmental meetings for planning.

Faculty members make session plan with tentative dates. Institutions academic calendar is prepared based on departmental calendar of all departments and various committees. College teachers build their knowledge by attending workshops, seminars, and conferences organized by other institutes. College library arranges to provide reference books, journals, and textbooks as per the revised syllabus. Teachers take extra efforts to ensure its effective implementation. Each department provides notices to display relevant information from time to time to students. The different methods and teaching aids used to ensure proper implementation of the curriculum. Use of various modern teaching aids for teaching. Institute organizes industrial visits, study tours, excursions, village surveys for a better understanding of the curriculum.

Various aspects of departmental activates are discussed such as preparation of teaching plans, departmental schedules, workload, distribution of the courses to be taught, add-on and skill based certificate courses, attending or organizing workshops on revised syllabus, preparing the list of required text books, reference books, journals and magazines or e-letters to be purchased for the library, various methods of teaching, use of ICT, internal evaluation, tutorials, practical, projects, field visits, study tours, guest lectures, departmental events, learning resource mobilization including the e-content, syllabus completion reports and result analysis etc. All departments submit all documents to IQAC for record keeping.

The HODs and subject teachers discuss the objectives, outcomes, and contents of the syllabus with the students at the beginning of each semester. Students are encouraged to participate in research competitions like Avishkar Research Convention, University youth festival, sports and other activities. Moreover our college prospects and magazine "Mohar" contains all the information regarding academic activities in addition to extra-curricular activities. Institute provides internet and Wi-Fi connection with two LCD projectors. In addition to this library, facilities are also available to the faculty and students. Library is well equipped with all subject textbooks, journals, reference books etc.

At the end of each academic year, the Feedback on curriculum is randomly collected from the employers, students, teachers, and alumni at the end of the academic year. These feedback forms are analysed and

action taken reports are prepared. Feedback on teaching-learning is received from students every year. It is analysed and action is taken in the form of using more student-centric methods and improving teachers' performance in the classroom.

To make effective teaching and learning process departments used various student centric methods. Experiential learning, participative learning and problem solving methodologies are used to ensure effective learning outcomes.

1.Experiential Learning – The college arranged several programmes for the students to experience the outside world and familiarize them with real-life situations.

1. Industrial visits / Hotel visits – The departments organize visits to the industrial and businesses plants. The major businesses in the locality are also explored. All departments interact with each other by emails.

2. Excursions – The department of Geography arrange excursions for better understanding of subject. In the excursions students learn and observe actual physical and manmade factors. In this visit, teachers used Google map to show how we reached from the college.

2. Participative Learning – Seminars, Presentations, Group Discussion, Google Classroom, and Case studies have been used by several departments to promote participative learning. Department of computer science and information Technology organises topic wise seminars and presentation to improve confidence. Almost all the academic departments use the platforms for continuous interaction with their students.

The college organized different group activities such as group discussions, inter college competitions, quiz contests, workshops, paper presentations, debate, poster making competitions, etc.

Students participate in organising events like Freshers meet, Farewell partys etc. During the annual college days students show their talents in the fields of sports, culture and literary arts. Students also actively take part in the University Youth festival where they get to compete with their peers of other colleges. Students take part in several extra and co-curricular activities like cleanliness drive, tree-plantation programme.

3. Problem solving method - Problem-solving methods are used by every department. In this process teachers give the projects to the students and they analysis their work. For data collection, data analysis, index writing, content writing teachers and students used computer.

2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The evaluation system is implemented as per the guidelines of the affiliating University of Mumbai. The University introduced Choice Based Credit System (CBCS). The Continuous Internal Evaluation System has been a part of the evaluation mechanism. The schedule is approved in the meeting of examination department and displayed on the notice board . Evaluation of projects includes project report, presentation and viva-voce.

Robustness in mechanism of internal assessment:

Additionally, to mandatory internal evaluation extra unit tests, open book tests, assignments, projects, viva-voce, tutorials, group discussions, seminars etc. are conducted. The internal /external examinations are conducted online/offline mode, monthly/ quarterly.

Additionally following system is adopted:

- The basic eligibility of evaluation of results is displayed on notice board.
- The continuous evaluation report display at respective notice boards.
- There is an established Examination Grievance Committee for examination related grievances.
- Schedule of Internal Assessment is communicated at the beginning of each semester.
- The internal evaluation process is communicated during Induction/Orientation program.
- The Class assessment, Test assignment, Project evaluation etc. answer sheet copies shown to student & discussed with them for improvement.
- The Academic committee / HOD and Principal regularly monitor Internal / External examinations and assessments.
- The College also furnishes photocopies of answer sheets to candidates on demand.

The university appoints external examiner for practical examination to make the whole process transparent.

Mechanism to deal with internal/external examination related grievances is transparent, time bound and efficient.

The examination committee of the college deals with the examination related grievances. The committee comprises of 5 members, the Principal him/her self being the chairman and other 4 members generally department heads. Hence, the grievances regarding the college level examinations are attended to and resolved within 3 to 4 days.

Students' unsatisfied, can apply for a photocopy of the answer-book and revaluation within seven days after the declaration of result. The photocopy or revaluation report is given within 15 days from the date of application. If the grievances are about university examinations then students can apply to Grievance Committee of University.

The Grievance handling procedure is executed as below;

- The examination Grievance Committee operates under Examination Department.
- Examination related grievance including, infrastructure, facilities, hall ticket, late arrived etc. are solved in accordance with the grievance system procedures.
- The Invigilator; where discussion is done & fair decision is taken, with relevance to the evidences communicates the Unfair behavior of the students in Examination Hall, to the Grievance Committee.
- The similar procedure is applicable for unfair behavior by the invigilator in examination hall; where in the complainant's (student) identity is hidden.
- Test results, Semester results are declared as per the mentioned Academic Calendar with stipulated time.

Thus, college helps the students in redressal of grievances related to the University and college examinations providing institutional support. There is a mechanism for redressal of grievances concerning evaluation both at the college and university levels.

Programme Outcomes (POs) and Course Outcomes (COs) for all Programmes offered by the institution are stated and displayed on website

Response:

S.P.Hegshetye College is affiliated to the University of Mumbai, the syllabus structuring, defining of objectives and framing the expected Programme outcome (PO), Programme Specific Outcome (PSO) and Course Outcome (CO) are carried out by the Board of Studies of respective courses in the syllabus framing meetings. This is communicated to all the affiliated Colleges through several workshops. The purpose of these outcome is to enervate students for their courses and programmes.

The POs represents knowledge, skills and attitude of students acquired by them, at the end of the programme. COs are the resultant knowledge and skills acquired by student at the end of a course. It defines the cognitive processes the course provides. POs PSOs & COs are uploaded on the College website for the knowledge of students. The COs are then printed in the prospectus for the benefit of the students and the parents.

The objectives of POs are displayed in all the departments prominently so as to enable teachers and students to plan the learning exercise in the classroom accordingly. The faculty members explain the learning objectives and expected outcome for each course at the beginning of the session as well as before starting the syllabus of each semester. This helps the students understand the topic being covered in the class and its relevance. PSOs of all the departments are highlighted through the achievements of shining stars of alumni after completion of the programme. The faculty members have established a strong communication channel with their respective chairpersons of the Boards of Studies. They clarify their doubts, if any, with them. The teachers also attend the syllabus revision workshops organized by the University and other colleges.

The record containing POs, PSOs and COs for all the programs offered by the College and same is made available at in all the departments for ready reference.

Apart from this, the College also communicates the objectives and importance of newly introduced POs, PSOs and COs to all the students, teachers and stakeholders through faculty workshops, College/departmental orientation programs, students induction programme, IQAC meetings, and faculty meetings. Most important the provision have been made by the institution in a timetable, that at the beginning of every semester, 3 lectures were conducted by HODs, related to POs, PSOs and COs.

Attainment of program outcomes and course outcomes are properly evaluated by the institution. The institute evaluates the specific outcomes of the programme with the help of additive evaluation mechanism. Formal as well as informal methods are used for the evaluation of the outcomes. Some of the methods used by the college for evaluation of the outcomes are result analysis, internal evaluation, questionnaires system and students' performance in classroom activities as well as in curricular and extracurricular activities, conducted at college and university level. Attainment of the outcomes are also evaluated from students' participation in higher studies and placements and teacher's informal communication with students. These attainments are evaluated at department, college and University level. The procedure of assessing the attainment of outcomes begins with defining the program outcomes discussing with the students.

Internal evaluation: Unit tests, practicals, projects, tutorials, assignments, seminars, group discussions, debates, field visits, open-book tests, oral tests, etc. are conducted for attainment of specific outcomes and evaluated from students performance. In addition to this successful participation and success in research competitions like Avishkar convention competition, contribution to specially designed literary /cultural programmes, performance in competitions like elocution, poetry recitation, quiz, debate, essay writing, poster exhibitions, presentations during value added courses, getting employments in various fields. Course outcomes are measured according to the performance of the students in the class, practical, internal evaluations and external evaluations.

Result analysis: Class wise and course wise the examination department does result analysis of the college level examinations. The results of the university examinations are analysed programme and course wise by the departments and then reported to the Principal and to the IQAC. All these results are discussed in the staff meetings, IQAC meetings and College Development Cell meetings.

Questionnaires system: At the end of every academic year the students Questionnaires on curriculum and teaching-learning process is collected and analysed by the IQAC. Inputs provided for Questionnaires on curriculum are clarity of outcomes, scope of curriculum, difficulty level, acquirement of skills, employability after learning it etc. Inputs for Questionnaires on teaching learning process are teaching methods, teachers knowledge, use of teaching aids, internal evaluation, etc. Besides this all the departments collect and analyse students' Questionnaires Reports of all these activities are submitted to IQAC.

In order to implement the plans and achieve desired goal, there are adequate facilities available in institution for teaching & learning. The institute has undergraduate programs in three faculties namely, Arts, Commerce, and Science. The Institute has created adequate infrastructure in terms of state of art computer labs, library, staff rooms and ICT classrooms. Also Cafeteria and Auditorium are available for students & staff members.

Institute has advanced and well equipped two computer labs with latest configuration. There are 50 computers are installed & functioning in both labs. The labs are well supported with latest software version and strong support of anti-viruses. The Labs are operating with 200 MBPS internet connection. The institute has all supportive equipments such as scanners, printers, Laptops, LCD projector etc. A power backup system is also installed in labs. The whole campus is under CCTV surveillance. The Institute also has a Geography lab for students.

Hospitality Studies department is having labs for their 4 major subjects which are front Office, Housekeeping, Food & Beverage Service & Food Production. Also for food production, HS department is having Basic Training Kitchen - **BTK** & Quantity Traing Kitchen - **QTK** for there practicals.

Library is a heart of any institute. The library is well furnished to create a pleasant environment for the students and staff. It plays vital role in enhancing the user's knowledge. The library has collection of Textbooks, References and Journals. The Built-up area of the library is 1390.84 Sq. m. The Library have 14959 books and 1441 reference books including Dictionaries, Encyclopedias and books on Literature. The library is enabled with **E-Granthalaya** freeware software. A separate reading section for students and staff is available.

There are 17 classrooms available in the institution, which is sufficient to engage theory classes. All the classrooms are well equipped with the required furniture. Along with classrooms, the institute have ICT enable classrooms. Classrooms are spacious, well ventilated. The seating capacity of classroom is sufficient with Televisions, LCD projectors, green & black boards. The institution have Jidnyasa Research Cell under the incubation center, Cultural room, WDC room, Sports room, Girl's & Boy's changing room, NSS room, Exam Room, DEPD section, IQAC room & Student Councilling room.

The campus has well equipped playground & gymnasium. A playground is available for various sports.

The students are provided with sports equipment such as Volleyball, Cricket, Kabbadi, Kho Kho etc. Dedicated grounds for sports like Volleyball, kabaddi, kho-kho and shot put are available. The Yoga room is available. The institution also has Counseling room, guest room, boys Changing room, ladies common room.

4.2 Library as a Learning Resource

4.2.1

Library is automated with digital facilities using Integrated Library Management System (ILMS),

adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

Response:

The Institution has a partially automated system of Library utilizing, Integrated Library Management System (ILMS) being implemented in year 2021. The system incorporates E-Granthalaya Version 3.0 (2007) as (Network Edition), which is developed & powered by National Information Center (Freeware software). E-Granthalaya software proves to be beneficial as it caters together various modules for in house operations including Acquisition, Cataloguing, Serial control, Circulation, MIS reports, OPAC. The process of automation is partial in nature, efficient and effective.

The library has internet with brodband speed of 200 MBPS (BSNL FTTH). Library has sufficient stacking area for Dewey Decimal Classification (DDC) of books. It has 14959 books, 16 journals, 8 newspapers visually displayed, thus creating a huge reading and learning material for the students and staff. Library hosts several events to encourage and motivate reading culture, awareness among students. One of the activity encompasses as "VACHASPATI"; in which "Best Reader" is nominated. The library also conducts Book exhibition displaying various books. Library functions under Advisory Committee for decision-making.

• E-Granthalaya: Objectives and Uses

E-Granthalaya is an integrated, multi-lingual package, which incorporates the in house operations of library. It has hands on access to library's reading material in the digitalization accession registers as well as records. It has many advantages as an Online Public Access Catalogue (OPAC), Books acquisitions, Circulation, Serials, Micro documents, Budgets, Search and status wise collectives.

• Library Management Software Modules and its Functions:

- Acquisition: This module allows users to choose books, construct searchable database. This module generates book title masters, requisitions, invoices, accessions, cancellations.
- Serial Control: Module helps to manage book subscriptions, renewals, cancellations, assuring accurate MIS reporting.
- **Circulation:** Module efficiently manages borrower categories by tracking book issues, returns, dues and Library books flow smoothly. This module also includes borrower details updates, visitor management, report generation such as issue book report, issue book quantity date-wise, all transaction reports.

• OER

OER serves as an Open Education Resources. There is availability of free content/ academic material for the access of the students. There are OER's on Management concepts like Motivation of young professionals at the workplace by OECD, Workplace performance, computer-learning concepts.

• OPAC

Users can search for books using keywords such as book's name, title, author etc. in Online Public Access Catalogue (OPAC). Users may quickly and easily retrieve information, improving their library

experience.

It contains reading hall that can accommodate 40 students, with separate arrangements for faculty, staff. It has an arrangement of bulletin board, which displays and important activities, data, daily information and periodical updates about library. It has also instructional boards on which library rules, Library committee, Timings are displayed for the information of students. It also has a visual display for Newspapers, Magazines and Journals.

Library functions are under Advisory Committee for decision-making and a sum of user each day throughout working days of a year divided by total working days of a year.

The college has well established mechanism for upgrading information technology infrastructure. IT infrastructure is provided to the administrative section, computer lab, library, examination section, classroom/smart class & seminar hall. Internet facility is provided to all students and faculty. All these facilities are continuously upgraded in the form of hardware updating, addition of bandwidth, replacement of high capacity cables, extension of continuous power supply facility etc. The college has BSNLFTTH with 200 mbps speed available.

The college has 04 Smart LED TV, 02 laptops, 60 computers (50 academic and 10 administrative work) 05 LCD projectors, 05 printers, 03 Printer with scanners, 2 Xerox machines. Backup system was installed for computers. The faculty and staff for regular teaching learning and administrative process use resources from various websites and web links. The college has procured necessary licensed softwares, especially for the administrative office and exam section. The Library is partially automated with e-

granthalaya freeware. The administrative office is connected through PRINCIPAL9 admission software, which is recently upgraded to meet the requirements thought LAN. The entire examination system is administered through e – governance with regularly updated software Result10. The administrative and examination section are provided backup facility through inverters. The Computer laboratory is well equipped with 50 desktop computers, 01 laptop and Inverters for backup in case of electricity power failure (3.5 KVA batteries backup). Antivirus softwares are installed and upgraded regularly.

E – Granthalaya software Developed & Designed by the National Information Center (Freeware software). The bibliographic information about the collection is made available through library OPAC system. The Library is also available online through OPAC.

The college has an active website administered and maintained by Beyond Web, Mumbai. It is updated regularly. Biometric system is introduced recording the attendance of teaching and nan- teaching staff. There are 16 CCTV cameras for security and surveillance purpose.

6.4 Financial Management and Resource Mobilization

6.4.1

The organization conducts regular financial audits. The organization has a formal mechanism for internal and external audit. Accounts are regularly audited to ensure financial submission. The College regularly conducts both internal and external financial audits. The College Management believes in continuous monitoring of the financial affairs of the College. The organization has a budgetary control system to monitor the effective and efficient use of financial resources. Many reforms were made in the financial administration of the organization. A financial committee headed by the principal and representing the management, teaching staff and administrative staff will try to find budgetary requirements from various departments and cells. The annual budget is prepared, reviewed and approved by the Finance Committee at the beginning of the academic year. The finance committee has fixed the total recurring and recurrent expenditure limits based on the income and resources of the organization. The organization regularly follows the internal and external financial audit system. Institutional accounts are regularly audited by internal and statutory audits. Qualified internal auditors are appointed and internal staff verifies all the vouchers of the transactions made in each financial year. The internal auditor should verify that the fees

have been collected from all the students and that the concession, if any, has been given by the authorized person. The internal auditor should also ensure that the fees received in advance and the fees receivable are properly accounted for and the non-reversible fees are written off under the authorization of the appropriate person. So far, no major objections have been raised in the financial audit, minor errors or omissions when pointed out by the audit team are immediately rectified and precautionary steps are taken to avoid recurrence of such errors in future. The auditor verifies the income and expenditure details of the college as per the Navnirman Shikshan Sanstha S.P.Hegshetye College, Ratnagiri on a balance sheet basis. The statutory external audit is carried out by a chartered accountant, who is specially appointed for this purpose.
